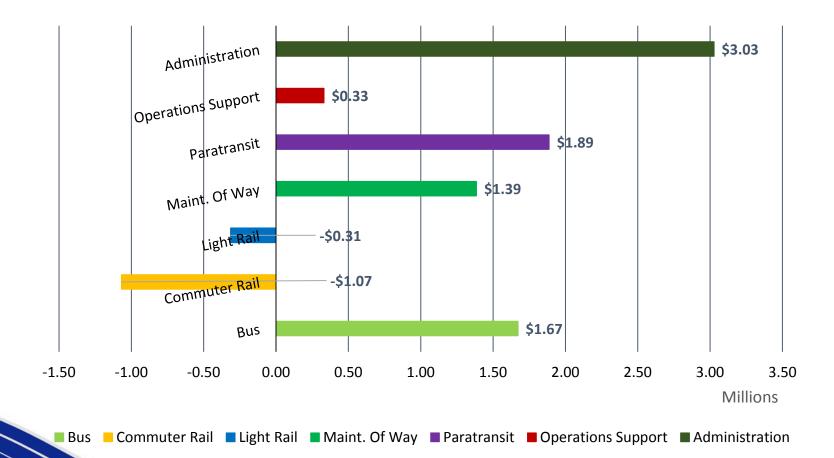


Sales Tax Collections

(2018 over 2017 for 12 months ended October 31)

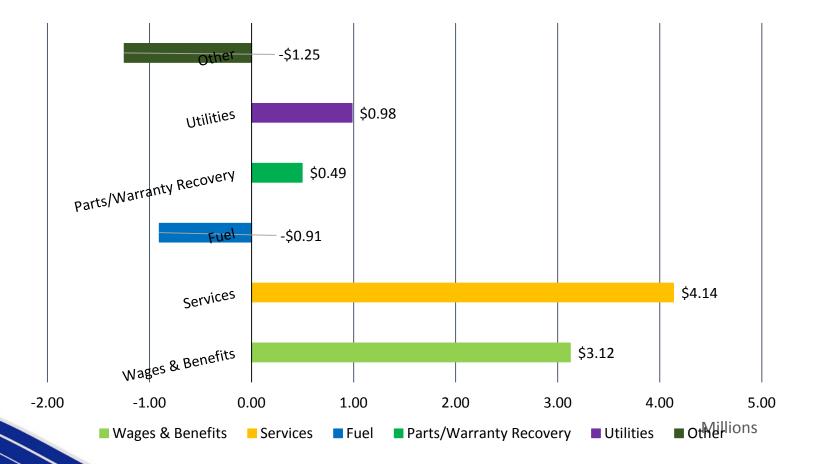


YTD 2018 Expense Thru September 30 Variance by Mode

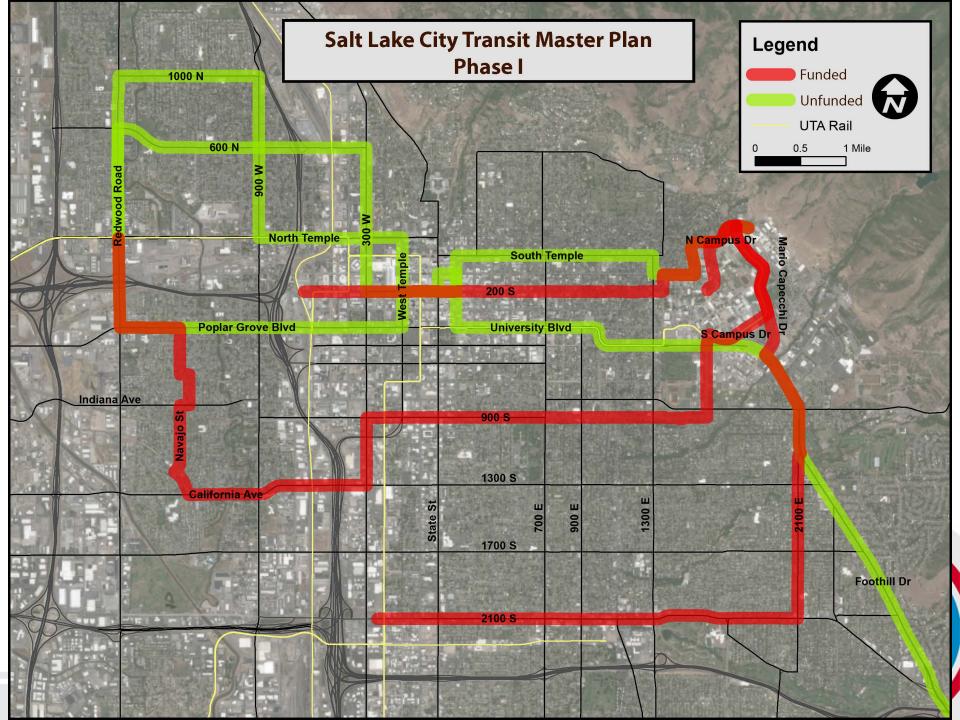

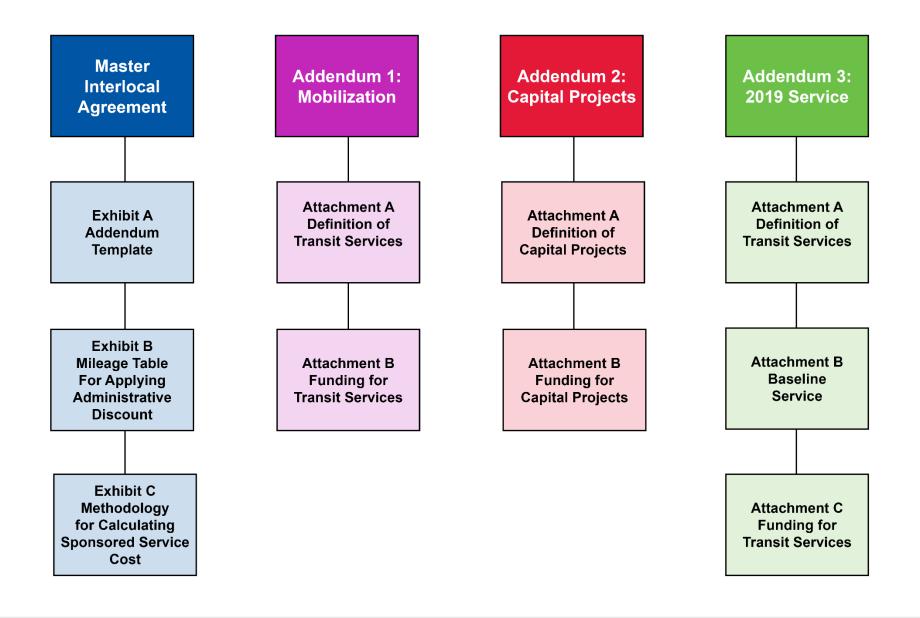
