- Hired a new executive director after a nationwide search
- New policies implemented to enhance accountability and transparency

 - Ski bus service expansion
 - Transit studies across Wasatch Front
 - 80 TIGER first/last mile projects completed

Minimal Change Scenario



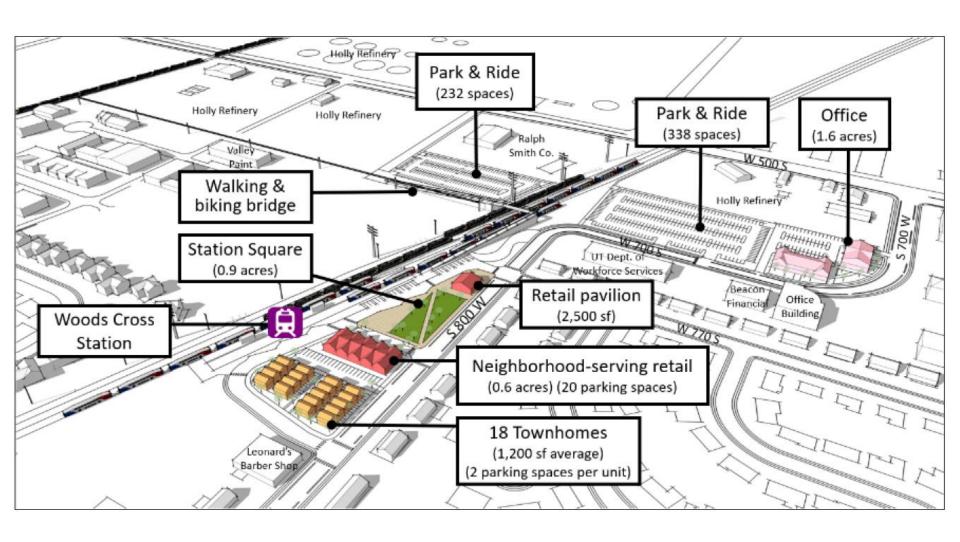
Moderate Change Scenario
