
Resolution Approving the Execution of an Interlocal Cooperation Agreement with Weber County and Ogden City for Right of Way Preservation Efforts to Extend Commuter Rail North of Ogden



Project Overview

- Ogden City and UTA requested funds from Weber County for corridor preservation for a future extension of FrontRunner to Business Depot Ogden (BDO). Funds would be used for survey work, document preparation and property acquisition.
- An infill station at BDO is included in the WFRC Long Range Plan
- Survey work is underway for Box Elder County right of way preservation. The consultant contract included an option to complete survey work in Weber County as well.







Interlocal Agreement Deal Points

- Weber County will award up to \$3,000,000 for right of way acquisition and survey work
- \$175,600 will be used for survey work by UTA; balance by Ogden for ROW preservation
- Funds are being awarded from the Weber County right of way account
- At the time a project is built, the preservation account for the property purchase and survey work will be reimbursed at the original price, up to \$3,000,000
- UTA will lead the survey work
- Ogden City will lead the property purchase process




